Name of Toxic Substance for which plan have been prepared

The Toxic Substance Reduction Plan has been prepared for one substance, Particulate Matter 2.5 (PM 2.5).

Statement of Intent

Celestica, a contract manufacturer, is committed to being a responsible neighbor in the communities in which we do business. The Toronto site is registered to ISO 14001 and a signed member of the Electronics Industry Citizenship Coalition (EICC) Code of Conduct. Wherever possible, and where practicable, we will eliminate or reduce the creation and discharge of Particulate Matter 2.5 (PM 2.5). We conduct our operations in compliance with applicable federal, provincial and municipal regulatory requirements. Celestica will continue to actively monitor technological developments that could assist in reduction of toxic substance usage. Where we determine that the developments are technologically and financially viable they will be considered for implementation.

PM 2.5 is mainly generated from natural gas combustion process which is used for steam production. In rare occasions where there is a shortage of natural gas fuel oil is used as an alternative energy source for steam production. A small amount of PM 2.5 is also generated from the manufacturing operations in which leaded solder products are being used.

Reduction Plan Objectives

Celestica already uses one of the most efficient and environmentally friendly natural resource to support their operations – natural gas. Although one reduction option was considered, it was determined not to be economically feasible so therefore Celestica will not reduce the level of PM 2.5 generation in the near future.

Description of Substance

As mentioned above, PM 2.5 is generated from natural gas combustion process. A small amount of PM 2.5 is also generated from the manufacturing operations in which leaded solder products are being used.

Toxic Substance Reduction Option to be Implemented

Although some reduction options were considered technically feasible, they were determined not to be economically feasible. As a result, there are no reduction options to be implemented at this time.
