Brief Description of Verification Process

SGS has been contracted by Celestica Inc. for the verification of direct and indirect carbon dioxide (CO₂) equivalent emissions as provided by Celestica Inc, 5140 Yonge St, North York, ON M2N 6L7, Canada, in their GHG statement in the form of a Greenhouse Gas Emissions Report covering CO₂ equivalent emissions.

Roles and responsibilities

The management of Celestica Inc is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS' responsibility to express an independent GHG verification opinion on the emissions as provided in the Celestica Inc GHG statement for the period Jan 1st 2022 to Dec 31st 2022.

SGS conducted a third-party verification following the requirements of ISO 14064-3: 2019 of the provided CO₂ equivalent statement in the period May -July 2023.

The assessment included a desk review and online meetings. The verification was based on the verification scope, objectives and criteria as agreed between Celestica Inc and SGS on 25th April 2023.

Level of Assurance

The level of assurance agreed is a limited level of assurance.

Scope

Celestica Inc has commissioned an independent verification by SGS of reported CO₂ equivalent emissions arising from their activities, to establish conformance with the requirements of WRI/WBCSD GHG Protocol and its amendments within the scope of the verification as outlined below. Data and information supporting the CO₂ equivalent statement were historical in nature and proven by evidence.

This engagement covers verification of emissions from anthropogenic sources of greenhouse gases included within the organization's boundary and meets the requirements of WRI/WBCSD GHG Protocol and its amendments.

- The organizational boundary was established following the operational control approach.
- Title or description of activities: Electronics manufacturing and supply chain management services.
- Location/boundary of the activities: Worldwide
- Physical infrastructure, activities, technologies and processes of the organization: Manufacturing facilities, product development facilities, storage and distribution facilities, offices.
- GHG sources, sinks and/or reservoirs included:
Scope 1: Direct GHG emissions and removals: Scope 1 – Stationary combustion.



Scope 2: Indirect GHG emissions from imported energy: Scope 2 – Purchased electricity.
Scope 3 : Fuel & Energy related activities not included in scope 1 or scope 2, Business Travel and Employee Commuting.

- Types of GHGs included: CO₂, N₂O, and CH₄
- Directed actions: none
- GHG information for the following period was verified: Jan 1st, 2022 – Dec 31st 2022.
- Intended user of the Verification Opinion: internal, customers, general, public, shareholders.

Objective

The purposes of this verification exercise are, by review of objective evidence, to independently review:

- Whether the CO₂ equivalent emissions are as declared by the organization's CO₂ equivalent statement
- That the data reported are accurate, complete, consistent, transparent and free of material error or omission.

Criteria

Criteria against which the verification assessment is undertaken are the requirements of WRI/WBCSD GHG Protocol and its amendments.

Materiality

The materiality required of the verification was considered by SGS to be below 10%, based on the needs of the intended user of the GHG statement

Conclusion

Celestica provided their GHG statement based on the requirements of WRI/WBCSD GHG Protocol and its amendments.

The GHG information for the period Jan 1st, 2022 – Dec 31st, 2022, disclosing gross emissions of 216,779 metric tonnes of CO₂ equivalent (Location based) and 107,113 metric tonnes of CO₂ equivalent (Market based) are verified by SGS to a limited level of assurance, consistent with the agreed verification scope, objectives and criteria.

Emissions per scope are as follows:

Scope 1: 9,860 tCO₂e

Scope 2: 135,471 tCO₂e (Location based)

Scope 2: 25,805 tCO₂e (Market based)

Scope 3:

Cat 3: Energy & Fuel related activities not included in Scope 1 or 2 : 38,542 tCO₂e

Cat 6: Business Travel: 4,737 tCO₂e

Cat 7: Employee Commuting: 28,169 tCO₂e

Celestica chooses to report their headline GHG Inventory total based on the market based scope 2 figure.

SGS' approach is risk-based, drawing on an understanding of the risks associated with modeling GHG emission information and the controls in place to mitigate these risks. Our examination included assessment, on a sample basis, of evidence relevant to the voluntary reporting of emission information.

SGS concludes with limited assurance that there is no evidence to suggest that the presented CO₂ equivalent assertion is not materially correct and is not a fair



representation of the CO₂ equivalent data and information and is not prepared following the requirements of WRI/WBCSD GHG Protocol.

We planned and performed our work to obtain the information, explanations and evidence that we considered necessary to provide a limited level of assurance that the CO₂ equivalent emissions for the period Jan 1st, 2022 – Dec 31st, 2022, are fairly stated.

This statement shall be interpreted with the CO₂ equivalent assertion of Celestica Inc as a whole.
