Below are the Portland freight routing instructions. The routing instructions listed here apply to all international and domestic shipments for which Celestica pays the freight charges.

For expedited shipping refer to the Expedited Routing section listed below.

- Carrier selection is based on chargeable weight, see instructions on page 2: Base the routing on total aggregate weight (Chargeable weight: e.g., dimensional and gross), not on the weight of each package.
- Multiple small packages shipped on the same day to Celestica must be consolidated with a heavyweight carrier: Combine multiple part numbers and purchase orders in one shipping container/on one pallet.
- Shipments of comparable size, height, and density that are difficult to handle, and for which the combined gross weight exceeds 150 pounds (68 kg) or are oversized should be crated or palletized.
- Consolidate items shipped on one day to the same destination on one pallet, one bill of lading, air waybill or ocean bill of lading.
- DO NOT insure or declare value on any shipment. Celestica carries insurance for all freight with its carriers. All freight charges will be billed back to the shipper if additional insurance is declared without Celestica's written authorization.
- The Celestica PO number must be referenced on the AWB/BOL when booking shipments with Celestica's carriers.
- ***PACKING SLIP REQUIRED TO BE PHYSICALLY ATTACHED TO ALL SHIPMENTS*** DOMESTIC & INTERNATIONAL.
- Deviation from the standard routing resulting in extra charges to Celestica will be charged back to the shipper; the shipper will be liable for excess charges or reversal of freight charges or both.
- Vendor-to-vendor (V2V) shipping (non Celestica locations) requires approval in writing; valid Celestica PO must be referenced on the AWB/BOL. Shipment without valid PO will be charged back to the shipper.
- International shipments must follow the Celestica commercial invoice requirements on page 2. Broker instructions below .

Import Compliance & International Commercial Invoice Requirements

1. Commercial invoice:

- a. Must be in English.
- b. Must describe the goods using language which completely and clearly identifies the content of the shipment.
- c. Quantities stated must be accurate.

2. Value of goods stated on invoice:

- a. Must correlate with the value of the Celestica Oregon purchase order.

3. Country of origin marking:

- a. All goods must be marked with the country of origin (e.g., "Made in Canada")
- b. Immediate packaging must be marked with the same country of origin.
- c. Commercial invoice must state the country of origin for each line item and must match the marking on the goods.
- d. Packing list must state the country of origin for each line item and must match the marking on the goods.

4. Packing list:

- a. Must be placed in an envelope or document pouch attached to each container.

All Commercial invoices must contain the following information or shipments will be held in US Customs or returned to the origin.

1. Shipper name and address
2. Sold to or invoice to name and address
3. Ship to name and address
4. Invoice number
5. Ship date
6. Carrier and way bill number (if info. available)
7. Incoterms
8. Celestica PO. Number or RMA number
9. Celestica part number
10. Description (complete, clear description of goods)*
11. Quantity (for each line item)
12. Unit price (for each line item)
13. Extended price (for each line item)
14. Country of origin (for each line item)**
15. Total value on the invoice
16. Weight and number boxes or skids.
17. Solid wood packaging statement if the goods ship from China or Hong Kong.

* Provide a detailed description of each item being shipped to ensure proper product classification per the Harmonized Tariff Schedule (HTS) and must include at a minimum: (i) The full name by which each item is known (ii) Part Number as appears on Purchase Order/Contract. If the item is a raw material, provide the material grade, class and dimensions. Generic descriptions, abbreviations, acronyms, and Stock Keeping Unit (SKU) numbers are not acceptable.

** Country of Origin of Goods – this is the country where the goods are manufactured. If a shipment contains goods with multiple countries of origin, each product must be itemized on the invoice and the country of origin must be indicated for each

Importer Security Filing Requirements (ISF):

In order to facilitate compliance with the U.S. Customs and Border Protection (CBP) - Importer Security Filing requirements for all ocean shipments, ensure that commercial invoices are provided to the Celestica preferred freight forwarder at time of

Weight Definitions and Calculations

Actual Weight:

- The weight of a package using a standard scale rounded to the next full pound / KG. (Example: a 12 1/2 pound carton will have an "actual weight" of 13 pounds).

Dimensional (Volumetric) Weight:

- A calculation used to reflect a package's density. The International Air Transport Association (IATA) volumetric standards is used to determine the dimensional weight.

- A calculation used to determine the three-dimensional space the carton occupies: length x width x height measured in cubic inches or cubic centimetres.

Chargeable Weight:

How to Calculate Volumetric Weight (International air shipments)

International Shipments Calculation

Imperial (IN / LBS) $\frac{\text{Length} \times \text{Width} \times \text{Height} = \text{Cubic Inches}}{166 \text{ (International)}}$

Metric (CM / KG) $\frac{\text{Length} \times \text{Width} \times \text{Height} = \text{Cubic Centimetres}}{6000 \text{ (International)}}$

Identifying what your chargeable weight will be:

Example - Imperial Calculation

Actual Pallet Weight = 250lbs

Pallet Dimensions = 48 x 40 x 50in

Pallet Volumetric weight = $(48 \times 40 \times 50) / 166 = 578.31\text{lbs}$

Chargeable Weight of shipment = 578.5lbs

Example - Metric Calculation

Actual Pallet Weight = 150kg

Pallet Dimensions = 122cm x 102cm x 120cm

Pallet Volumetric weight = $(122 \times 102 \times 120) / 6000 = 248.88\text{kg}$

Chargeable Weight of shipment = 249kg

How to Calculate Volumetric Weight (USA Domestic air shipments)

Imperial (IN / LBS) $\frac{\text{Length} \times \text{Width} \times \text{Height} = \text{Cubic Inches}}{166 \text{ (USA Domestic)}}$ 578.313253

Example - Imperial Calculation

Actual Pallet Weight = 250lbs

Pallet Dimensions = 48 x 40 x 50in

Pallet Volumetric weight = $(48 \times 40 \times 50) / 166 = 578.31\text{lbs}$

Chargeable Weight of shipment = 578.5lbs

or

Example - Imperial Calculation

Actual Pallet Weight = 600lbs

Pallet Dimensions = 48 x 40 x 50in

Pallet Volumetric weight = $(48 \times 40 \times 50) / 166 = 578.31\text{lbs}$

Chargeable Weight of shipment = 600lbs

Length or Girth - (For Domestic USA shipments with FedEx, Air and Ground)

Your Chargeable weight will be based on the greater between the actual package weight and the Length and Girth of the package.

Length - is the largest dimension of the carton or object being shipped. For example, if the package is very tall (height is greater than the base) use the height as the length.

Girth - is the sum of 2 times the width plus 2 times the height or the measurement around the largest area of the cylinder (see illustration).
