#### **Brief Description of Verification Process**

SGS has been contracted by Celestica Inc. for the verification of direct and indirect carbon dioxide (CO<sub>2</sub>) equivalent emissions as provided by Celestica Inc, 5140 Yonge St, North York, ON M2N 6L7, Canada, in their GHG Assertion in the form of a Greenhouse Gas Emissions Report covering CO<sub>2</sub> equivalent emissions.

#### Roles and responsibilities

The management of Celestica Inc is responsible for the organisation's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS' responsibility to express an independent GHG verification opinion on the emissions as provided in the Celestica Inc GHG Assertion for the period 01/01/2020 – 31/12/2020.

SGS conducted a third-party verification following the requirements of ISO 14064-3: 2006 of the provided CO<sub>2</sub> equivalent assertion in June to July 2021.

The assessment included a desk review of information provided from Celestica Inc's Head Office in Toronto. The verification was based on the verification scope, objectives and criteria as agreed between Celestica Inc and SGS on 26/04/2021

#### Level of Assurance

The level of assurance agreed is a limited level of assurance.

#### Scope

Celestica Inc has commissioned an independent verification by SGS of reported CO<sub>2</sub> equivalent emissions arising from their activities, to establish conformance with the requirements of the WRI/WBCSD GHG Protocol and its amendments within the scope of the verification as outlined below. Data and information supporting the CO<sub>2</sub> equivalent assertion were historical in nature and proven by evidence.

This engagement covers verification of emissions from anthropogenic sources of greenhouse gases included within the organization's boundary and meets the requirements of the WRI/WBCSD GHG Protocol and its amendments.

## Title or description activities:

- The organizational boundary was established following the operational control approach.
- Title or description of activities: Electronics manufacturing and supply chain management services.
- Location/boundary of the activities: Worldwide.
- Physical infrastructure, activities, technologies and processes of the organization: Manufacturing facilities, product development facilities, storage and distribution facilities, offices.
- GHG sources, sinks and/or reservoirs included:



Scope 1 - stationary combustion; Scope 2 - purchased electricity; Scope 3 - air travel

- Types of GHGs included: CO<sub>2</sub>, N<sub>2</sub>O, CH<sub>4</sub> (HFC's, PFC's, SF<sub>6</sub> and NF<sub>3</sub> are excluded)
- Directed actions: none
- GHG information for the following period was verified: 01/01/2020 31/12/2020.

Intended user of the verification statement: internal, customers, general, public, shareholders

#### Objective

The purposes of this verification exercise are, by review of objective evidence, to independently review:

- Whether the CO<sub>2</sub> equivalent emissions are as declared by the organization's CO<sub>2</sub> equivalent assertion
- That the data reported are accurate, complete, consistent, transparent and free of material error or omission.

#### Criteria

Criteria against which the verification assessment is undertaken are the requirements of WRI/WBCSD GHG Protocol and its amendments.

#### Materiality

The materiality required of the verification was considered by SGS to be below 10%, based on the needs of the intended user of the GHG Assertion.

#### Conclusion

Celestica Inc provided the GHG assertion based on the requirements of WRI/WBCSD GHG Protocol and its amendments. The GHG information for the period 01/01/2020 - 31/12/2020 disclosing gross emissions of 62,157 metric tonnes of  $CO_2$  equivalent are verified by SGS to a limited level of assurance, consistent with the agreed verification scope, objectives and criteria.

## Emissions by scope are as follows:

Scope 1 (Direct): 8,925 tCO2e

Scope 2 – Location-based (Indirect): 140,762 tCO<sub>2</sub>e Scope 2 – Market-based (Indirect): 52,687 tCO<sub>2</sub>e

Scope 3: 545 tCO<sub>2</sub>e

Celestica chooses to report their headline GHG Inventory total based on the market-based Scope 2 figure.

SGS' approach is risk-based, drawing on an understanding of the risks associated with modeling GHG emission information and the controls in place to mitigate these risks. Our examination included assessment, on a sample basis, of evidence relevant to the voluntary reporting of emission information.

SGS concludes with limited assurance that there is no evidence to suggest that the presented CO<sub>2</sub> equivalent assertion is not materially correct and is not a fair



representation of the CO<sub>2</sub> equivalent data and information and is not prepared following the requirements of WRI/WBCSD GHG Protocol and its amendments.

We planned and performed our work to obtain the information, explanations and evidence that we considered necessary to provide a limited level of assurance that the  $CO_2$  equivalent emissions for the period 01/01/2020 - 31/12/2020 are fairly stated.

This statement shall be interpreted with the  $CO_2$  equivalent assertion of Celestica Inc as a whole.
